

# SHELL TOP GUN: MAVERICK PROMOTION TERMS AND CONDITIONS

**These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry and claim instructions are deemed to form part of the Terms and Conditions. Please retain a copy for your information.**

## 1. Eligibility

- 1.1 This Promotion is only open to residents of Great Britain (England, Scotland and Wales) aged 18 or over who are (or, prior to entry, become) members of the Shell Go+ loyalty scheme operated on behalf of the Promoter and its associates and who are not employees of the Promoter or of any agent of the Promoter retained in connection with the administration of, or supply of prizes for, the Promotion ("eligible person").
- 1.2 Entrants are required to purchase any amount of Shell V-Power fuel from a participating Shell station.
- 1.3 Entrants must have a registered Shell Go+ email address to enter.
- 1.4 Customers can collect a promotional card at participating Shell service stations without being a Shell Go+ member. However, customers must register with the Shell Go+ rewards programme before entering the promotion on the promotional website.
- 1.5 Any person found to be acting in breach of these terms and Conditions and/or concert as a syndicate, consumer group or otherwise and any person entering via an agent or using the services of, or which is an entity carrying on the business of, entering (or advising on entering) prize promotions, will be disqualified. Bulk entries will not be accepted. If it becomes apparent that a participant is reposting the same content multiple times or using a computer(s) to circumvent this or any other condition by, for example, the use of 'script', 'brute force' or any other automated means, that person's entries will be disqualified and any prize award will be void.

## 2. Promotional periods

- 2.1 The Promotion will run from 00.01 on 05.05.22 to 23:59 on 29.06.22 ("Promotional Period").
- 2.2 Prize draws will occur weekly throughout the promotional period with dates outlined in point 5.3 of these terms. Eight prize draws will occur in total.
- 2.3 All entries received after the respected end date will be disqualified.

## 3. How to enter

- 3.1 Purchase any amount of Shell V-Power fuel at a participating Shell service station ("**Qualifying Purchase**") (see <https://www.shell.co.uk/motorist/shell-station-locator.html> for your nearest participating service station) during the promotional period to receive a promotional card with a unique code for the chance to win.
- 3.2 Visit [www.shell.co.uk/win](http://www.shell.co.uk/win) and log into your Shell Go+ account or register to sign up. You must then enter your unique code from the gamecard and accept terms and conditions on the website to enter. Entry on [www.shell.co.uk/win](http://www.shell.co.uk/win) does not have to be on the same day as the Qualifying Purchase but will still need to be within the Promotional Period.
- 3.3 1 promotional card per purchase, maximum 3 entries per week per account transaction. Weeks are outlined in section 5.3 of these terms. Unique code can only be used once. Only one mobile phone number and email address will be accepted per person. Any entrant using multiple mobile phone numbers/email addresses to access the Promotion will be disqualified and any prize entitlement will be void.
- 3.4 Entries to this promotion will only be eligible if they originate from a Participant using their Shell Go+ account themselves. For the avoidance of doubt, if a participant allows another party to use their Shell Go+ account, any entries made by such other party will not be eligible for this Promotion.
- 3.5 The Promotion will run while stock of promotional cards last. If a participating Shell service station runs out of stock of promotional cards, the Promotion shall continue to run across all other participating Shell service stations that still have promotional cards in stock during the Promotional Period.

## 4. Prizes

- 4.1 There are 213 prizes consisting of:  
2 x VIP Top Gun: Maverick experience – including 2-nights (Fri-Sun) self-catering accommodation with a breakfast hamper and a bespoke 3-course dinner prepared and delivered by a top chef on one evening. Military style PT session with a top trainer (2-hours) including a nutritional meal plan to take away. A flight simulator experience and learn to fly your own plane. Safety briefing, equipment and flight suit hire included. Prize offered is for 2 adults travelling together, one of which must be aged 18 or over. The experience is not permitted over Christmas, New Year, Easter, Bank Holidays, trade fairs or local special events (i.e. Fashion Week / Sporting Events). Travel must be completed within 12 months of notification of prize. Extensions to the validity of the package will not be allowed unless first authorized by Cloud Nine Incentives Limited and the Promoter. All dates and locations are subject to availability at the time of booking. Cloud Nine accepts no responsibility for any events beyond its reasonable control including the withdrawal of, or amendment to, any restaurants, hotels, activities, events or retail items. Cloud Nine will use its reasonable endeavours to supply suitable alternatives in such circumstances. No refund will be offered. ## 5. Winner selection and Notification

### Prize Draw

- 5.1 There are 213 prizes guaranteed to be won during the Promotional Period.
- 5.2 Physical prizes will be despatched within 28 business days of the winners confirming their postal address for delivery.

- 5.4 Winners will be notified by phone or email within 7 business days of the draw with details of how to claim their prize. Winners have 14 days to claim their prize from the date of the notification.
- 5.5 Winners of Shell V-Power rewards will be notified of their prize via email within 15 business days of the draw, and rewards will appear in their Shell Go+ account at the same time.
- 5.6 In the event that a winner of a prize draw cannot be contacted within the initial notification period, the Promoter will attempt to contact a winner a maximum of 3 times within 14 days of the respected draw. If the Promoter is unable to contact a winner, or any winner fails to claim their prize, the Promoter reserves the right to disqualify that winner. In the event that a winner is disqualified, the Promoter reserves the right to allocate the prize to a reserve winner selected in the same manner. Reserves may have less time to respond.

## 6. General Terms

- 6.1 No third party or bulk entries. Entries via third parties or syndicates, entries by macros or other automated means and entries which do not satisfy the requirements of these Terms and Conditions in full will be disqualified.
- 6.2 If it becomes apparent in the reasonable opinion of the Promoter that any entrant or the entrant's household is using any means to circumvent this condition such as, and without limitation, fraudulently falsifying data, using identities other than their own, using any other automated means in order to increase that entrant's entries, or otherwise acting dishonestly, fraudulently or otherwise in violation of these terms, such entrant will be disqualified, and any prize entitlement will be void.
- 6.3 No responsibility will be accepted for entries that are incomplete, lost, corrupted, delayed or not received for whatsoever reason.
- 6.4 Promoter's decision is final and binding in relation to all matters relating to the Promotion. No correspondence will be entered into.
- 6.5 By entering this Promotion the entrant agrees to be bound by these Terms and Conditions.
- 6.6 Instructions provided at the point of entry form part of the Terms and Conditions of this Promotion. In the event of a conflict, these Terms and Conditions take precedence.
